



The reality is that tiger numbers have undoubtedly grown in numbers over the last decade, thanks to both a successful conservation and protection strategy by the Forest Department, but it's also been greatly enhanced by the sustained economic funding for park protection and for local communities that tigers have brought to these parks by the nature tourism sector, through visitor fees, job creation, local enterprises, improved infrastructure and increased taxes for local governments.

Tourism has instead made tigers hugely valuable - living legends indeed - economic drivers for once marginalised village communities around once denuded and unloved protected areas like Nagarhole and Bandipur. In 2010 TOFT India published in the Indian media that a single tigress can generate over INR 900 crore in her lifetime within a Rajasthan park, no doubt a similar figure to tigers in Nagarhole. Furthermore, our own published research (see attached) in 2018 in Madhya Pradesh and Rajasthan highlighted that village communities revenues, with or besides tourism infrastructure, were eight times higher than those villagers without such tourism benefits or enterprises. At this moment, thousands of critical local jobs that have been created – and are now hugely threatened and in dire distress – by the ridiculous notion that Karnataka's nature tourism sector somehow is the cause of this man-animal conflict.

We would urge at once that the all parks are reopened to safari and boat tourism, before all the direct and indirect benefits of nature tourism are lost to Karnataka and its protection sector, and more especially its bordering communities.

Nature tourism has been the powerful monetary engine behind the government's extraordinary success in conserving tigers, and the job now is to use it better and more wisely to restore more landscapes back to nature, for this expanding tiger population with all the other benefits of water, clean air and soil health that this brings, and NOT blame or shut down the very driver of this world beating success.

We appreciate any action you can do in resolving this issue and in changing the misinformed narrative.
